In the event that the matter is referred to a Judicial Hearing Officer (JHO) or a Court Attorney/Referee, such JHO or Court Attorney/Referee is given the jurisdiction to hear and report all issues to the undersigned and/or to hear and resolve all issues.

Notwithstanding anything to the contrary, attorney for movant shall serve a copy of this order, with notice of entry, on the **defendants by regular and certified mail**.
