Plaintiff's unopposed motion pursuant to CPLR §3215 for a default judgment for the relief demanded against them in the complaint is granted as to the following named defendants: Terrain T. Bloomfield, Cary Small, Matthew Lloyd, Carey Richards, You Deng Hui, Central Radiology Services, P.C., A-Quality Medical Supply, Inc., City Dental Services, P.C., Ave. K. Medical P.C., A.S. Acupunture, P.C., Synergy First Medical PLLC, Sky Chiropratice, P.C., Dovphil Anesthesiology Group, Modern Chiropractic, P.C.

Pursuant to CPLR §306-b, plaintiff's time to serve the defendants Jian Xia Gu and Asnodin Dianalan, PT, (the Unserved Defendants) is extended *nunc pro tunc* for an additional 150 days from February 28, 2009.

Pursuant to stipulation, the actions against defendant Kingshwy Psychological, P.C., and Unique Chiropractic P.C., have been discontinued. The names of these two defendants are deleted from the caption.

Pursuant to CPLR 603, the action is severed as to the defaulting defendants and shall continue as to the non-defaulting defendants.

The request for attorneys fees is denied as to the defaulting defendants, since plaintiff failed to direct the Court to any contractual or statutory authority to support such request. Siamos v. 36-02 35th Ave. Development, LLC, 54 AD3d 842 (2d Dept. 2008).

Plaintiff's application pursuant to CPLR §308-5 for service by publication upon the Unserved Defendants is denied, with leave to renew. Plaintiff has failed to submit an adequate affidavit demonstrating that service is impractical under paragraphs one, two and four of CPLR §308, See Dobkin v. Chapman, 21 NY2d 490 (1968); Contimortgage Corp. v. Isler, 48 AD3d 732 (2008), by any person with knowledge which reflects the efforts made to locate and serve the defendants for whom such relief is requested. The pre-printed forms with checked boxes submitted by a process server do not comport with requirements for such

relief and the Court notes that the so called affidavits with respect to Asnodin Dianalan, PT are not signed.

This shall constitute the Decision and Order of this Court.
