Application by plaintiff pursuant to CPLR 3215 for a default judgment against defendants LYNBROOK ADV ACUPUNCTURE, P.C., HEALTHY LIFE CHIROPRACTIC, P.C., PROHEALTH ACUPUNCTURE, P.C., SHERYL R. TOMACK, PHYSICIAN, LLC, s/h/a SHERYL TOMACK, PHYSICIAN, LLC, BTS MEDICAL, P.C., ELEMAM PHYSICIAN, P.C., GREENWAY MEDICAL SUPPLY, INC and BIG APPLE CHIROPRACTIC, P.C. is granted. No opposition to the application has been submitted by defendants. The action against IDK IMAGING, P.C. has been discontinued.

In this action, plaintiff, a no-fault insurance carrier, seeks a declaratory judgment

motor vehicle accident that occurred on March 21, 2010, and that none of defendants or their assigns are entitled to first-party no-fault benefits. Treatment was purportedly sought from the medical provider defendants for injuries alleged to have been sustained as a result of the accident which occurred on March 21, 2010.

All of the defaulting defendants were served with the Summons and Verified Complaint. Counsel for plaintiff states that the defaulting defendants have failed to appear or otherwise move with respect to the complaint.

Plaintiff challenges its obligation to provide coverage alleging that the insured made material misstatements in her application. In support of plaintiffs' claim, it submits an affirmation of counsel and affidavits of Keith Miller and Keith Wilson, employees of plaintiff, as well as a copy of the verified complaint (Ex. A).

It is alleged that a certain policy of insurance was issued to Inger Grant ("Grant") providing no-fault coverage. Plaintiff alleges in its complaint that defendant Grant stated in her application that she resided at 143 South Maplewood Road, Monticello, New York 12701 but stated on the police report that she resided at 972 Sherman Avenue, Bronx, New York 10456.

It is alleged in the complaint that during an investigation, defendant Grant admitted that the vehicle was registered to the Bronx address where she resided. Mr. Miller avers that the policy would not have been underwritten at the rate charged had plaintiff known of the actual residence address. On April 30, 2011, plaintiff denied the claims based upon the material misrepresentations.

Based upon all of the foregoing, plaintiff's motion for a default judgment is granted.

Submit declaratory judgment.

This decision constitutes the order of the court.
