This is an action for personal injuries sustained by plaintiff Nicolas Wahl in a slip and fall accident occurring on July 13, 2005. A preliminary conference Order was issued by the Court on April 19, 2007. On October 26, 2007, plaintiff Nicholas Wahl passed away and consequently the action was stayed pending the issuance of letters of administration. On November 26, 2007, the Court system marked the case "disposed" which plaintiff's counsel asserts was a result of a ministerial error.

Plaintiffs now move to restore this action to active status and for an Order pursuant to CPLR §1015(a) and §1021 permitting the substitution of Alice Wahl, as Administratrix of the Estate of Nicholas Wahl upon the ground that plaintiff Nicholas Wahl is now deceased. Plaintiffs submit a copy of Limited Letters of Administration, dated May 28, 2008, appointing Alice Wahl Limited Administrator of the Estate of Nicholas Wahl. Defendant's counsel has informed the Court that defendant will not oppose the motion. Upon the foregoing papers, and after due consideration, it is

ORDERED, that the motion to restore this action to active status is granted; and it is further

ORDERED, that the motion to substitute Alice Wahl, as Administratrix of the Estate of Nicholas Wahl, as plaintiff in this action, in the place and stead of Nicholas Wahl is granted, and it is further

ORDERED, that all papers, pleadings and proceedings in this action shall be amended accordingly, and that the caption shall read as follows:
