PATRICIA GLASNER, COUNTY OF NASSAU and NASSAU COUNTY DEPARTMENT OF
PARKS AND RECREATION. The plaintiff subsequently discontinued against Nassau County and
Nassau County Department of Parks and Recreation and served a Second Amended Verified
Complaint on MIKE TSOUKATOS, an infant over the age of fourteen, by his Parent and Natural
Guardian, GEORGE TSOUKATOS. Pursuant to a "so ordered" stipulation dated
April 28, 2005, a Supplemental Summons and Third Amended Complaint were served on MIKE
BANTEL and upon DEBRA BANTEL.

On or about May 11, 2005, defendant JOSHUA GLASNER by PATRICIA GLASNER served a Verified Answer to the Third Amended Complaint, including cross claims for contribution and indemnification upon and against MIKE BANTEL by DEBRA BANTEL.

MIKE BANTEL and DEBRA BANTEL have not appeared or answered the within action nor has their time been extended to Answer or Appear. The plaintiffs have provided an Affidavit of Service indicating that their Notice of Motion was served on the Defendant on June 20, 2005. The GLASNER defendant has provided an Affidavit of Service indicating that his Notice of Motion was served on the BANTEL Defendants on July 22, 2005.

The Court has not received any opposition to the motions. As such, both the plaintiff's and the GLASNER defendant's applications are **granted**.

The inquest on damages against MIKE BANTEL and DEBRA BANTEL is held in abeyance until the time of the full trial of this matter.

This constitutes the **Decision** and Order of this Court.
