affirmed the 26th day of March, 2007, the annexed Affirmation for Emergent
Relief, affirmed the 26th day of March, 2007, the annexed Memorandum of Law,
dated March 26, 2007, and the exhibits annexed hereto, including the Summons
and Complaint against Defendant, and upon all of the prior pleadings and
proceedings heretofore had herein,

LET Defendant, or his counsel, show cause before this Court at an IAS
Term, Part ^{43 (Rm 362)} thereof, to be held at the Courthouse located at 360 Adams Street,

(c) forming any other website domains solely or primarily for the purpose of publishing any matters concerning Plaintiff GK Grill LLC d/b/a Le Marais, and its owners, managers, employees, or kosher certification thereof;

(d) publishing any further statements, editorials, matters, images, pictures, letters, notes, reports or other documents in any newspapers, magazines, or other print media concerning Plaintiff GK Grill LLC d/b/a Le Marais, and its owners, managers, employees, or kosher certification thereof; and

(e) granting such other and further relief as this Court deems just and proper. Accordingly, it is

ORDERED that, pursuant to CPLR 6313, pending the hearing and determination of this Order to Show Cause, Defendant, together with any of his servants, agents, attorneys, registrars, or assigns, is hereby enjoined and restrained from:

(a) publishing or posting any further statements, matters, images, pictures, letters, notes, reports or other documents on the website domain name of “amashgiachspeaksout.com;”

(b) publishing or posting any further statements, matters, images, pictures, letters, notes, reports or other documents on the web log name of “amashgiachspeaksout.blogspot.com;”;

(c) forming any other website domains solely or primarily for the purpose of publishing any matters concerning Plaintiff GK Grill LLC d/b/a Le Marais, its owners, managers, employees, or kosher certification thereof;


