UPON the annexed affirmation of Jason Y. Goodstein, affirmed the 26th day of January, 2011, the affidavit of Rabbi Simcha Klor sworn to on the 26th day of January, 2011, the exhibits annexed hereto; the summons and verified complaint; and all the prior proceedings heretofore had herein;

LET defendants show cause at IAS, Part 13, Room 441 of this Court to be held at the Courthouse, located at 360 Adams Street, Brooklyn, New York on the 25 day of ~~January~~/February, 2011 at 9:30 a.m., or as soon thereafter as counsel can be heard, why an Order should not be made:

(1) pursuant to CPLR § 6301 et seq., enjoining and restraining Defendants SHLOMEY KLOR a/k/a STANLEY KLOR and MOSHE KLOR, and/or their agents, servants, employees and attorneys from transferring, withdrawing, surrendering, selling, cashing in,

hypothecating or otherwise altering or moving any and all assets of Yeshiva of Kings Bay Inc., including, but not limited to, any and all bank accounts, whether known or unknown at this time, credit accounts, safety deposit boxes, stock certificates, dividends, annuities and other financial and personal assets pending further order of this Court; and

(2) for such other, further and different relief as to the Court may seem just, proper and equitable.

STAY
ORDERED that Defendants SHLOMEY KLOR a/k/a STANLEY KLOR and MOSHE KLOR, and/or their agents, servants, employees and attorneys are temporarily restrained pursuant to CPLR § 6313 from transferring, withdrawing, wiring, surrendering, selling, cashing in, hypothecating or otherwise altering or moving any and all assets of Yeshiva of Kings Bay Inc., including, but not limited to, all bank accounts, whether known or unknown at this time, credit accounts, safety deposit boxes, stock certificates, dividends, annuities and other financial and personal assets pending the ~~determination~~ *HEARING* of this application; and it is further

FMW JSC
ORDERED that all bank accounts and safety deposit boxes, whether known or unknown at this time, owned by, or held in the name of, YESHIVA OF KINGS BAY INC. be frozen pending the ~~determination~~ *HEARING* of this application, except for five (5) bank accounts currently held in the name of YESHIVA OF KINGS BAY INC., which five (5) bank accounts shall remain unfrozen, specifically, Citibank account nos. 9955565291 and 74431209; JPMorgan Chase Bank account nos. 1882124977 and 830991741; and Banco Popular account no. 6803005724.

SUFFICIENT CAUSE being alleged, let service of a copy of this order together with the papers upon which it is granted be made upon the defendant SHLOMEY KLOR a/k/a
