Upon compliance with proof of service and running of the 30-day period of stay, this case shall continue as scheduled per the Preliminary Conference Order. All parties shall appear at the Compliance Conference before the undersigned at the County Courthouse, 262

Old Country Road, 3rd Floor, Mineola, N. Y. on July 8, 2002 at 9:30 A.M. No adjournments of this conference will be permitted absent the permission of or Order of this Court. All parties are forewarned that failure to attend conference may result in the dismissal of pleadings (see 22 NYCRR 202.27) or monetary sanctions (22 NYCRR 130-2.1 et seq).
