Per Curiam.

Elizabeth Marie Hugetz was admitted to practice by this Court in 2015 and lists a business address in Roxbury, Massachusetts with the Office of Court Administration. Hugetz now seeks leave to resign from the New York bar for nondisciplinary reasons (*see* Rules for Attorney Disciplinary Matters [22 NYCRR] § 1240.22 [a]). The Attorney Grievance Committee for the Third Judicial Department (hereinafter AGC) advises that it does not oppose Hugetz's application.

Upon reading Hugetz's affidavit sworn to September 28, 2022 and filed October 26, 2022, and upon reading the November 4, 2022 correspondence in response by the Chief Attorney for AGC, and having determined that Hugetz is eligible to resign for

nondisciplinary reasons, we grant her application and accept her resignation.

Egan Jr., J.P., Clark, Pritzker, Ceresia and McShan, JJ., concur.

ORDERED that Elizabeth Marie Hugetz's application for permission to resign is granted and her nondisciplinary resignation is accepted; and it is further

ORDERED that Elizabeth Marie Hugetz's name is hereby stricken from the roll of attorneys and counselors-at-law of the State of New York, effective immediately, and until further order of this Court (*see generally* Rules for Attorney Disciplinary Matters [22 NYCRR] § 1240.22 [b]); and it is further

ORDERED that Elizabeth Marie Hugetz is commanded to desist and refrain from the practice of law in any form in the State of New York, either as principal or as agent, clerk or employee of another; and Hugetz is hereby forbidden to appear as an attorney or counselor-at-law before any court, judge, justice, board, commission or other public authority, or to give to another an opinion as to the law or its application, or any advice in relation thereto, or to hold herself out in any way as an attorney and counselor-at-law in this State; and it is further

ORDERED that Elizabeth Marie Hugetz shall, within 30 days of the date of this decision, surrender to the Office of Court Administration any Attorney Secure Pass issued to her.
